

### Holdinga Matthijssen Kraak Cookie Statement

Holdinga Matthijssen Kraak B.V. makes use of cookies on its website [www.hmknotarissen.nl](http://www.hmknotarissen.nl). This cookie statement explains what cookies are, which cookies are used on the website of Holdinga Matthijssen Kraak B.V., how you can remove cookies and how you can contact us.

#### 1. What are Cookies?

Cookies are small (text) files that are stored on your computer, tablet, smartphone or other electronic device (hereinafter: "computer") when you visit a website. Storing a cookie on your computer enables the server to recognise your computer and to collect information such as your IP address and browsing habits. Once a cookie is stored on a computer, it is valid for a certain period of time. When this validity period expires, the cookie is deleted by your browser. Some cookies are only valid for the duration of the browser session, but other cookies remain valid longer so they can be accessed during subsequent visits to our website.

#### 2. Cookies on our website

Our website places analytical cookies. Holdinga Matthijssen Kraak B.V. uses the Google Analytics service of Google LLC ("Google") for this purpose.

Google Analytics helps us gain insight into how our website is used. This includes user statistics and reports on the number of different visitors, the pages that are frequently visited and the average length of a visit. These statistics can be used to analyse the use of our website. We use this knowledge to make our website easy to use and to modify and improve (the information offered on) our website.

Our Google Analytics setting is "privacy-friendly" in accordance with the [guideline of the Dutch Data Protection Authority](#). Among other things, this means that we: have entered into a processing agreement with Google, use the Anonymize IP feature which removes the last three digits of your IP address, have disabled data sharing options, and do not use other Google services in conjunction with Google Analytics.

As a result, these cookies have little impact on your privacy and can therefore be placed without consent. The personal data we collect by means of cookies are processed in accordance with our privacy statement.

The following is an overview of the analytical cookies:

_utmz	hmknotarissen.nl	Records information about how the visitor arrived at the website (i.e. which search engine).	6 months
